**Chronic Inhalation:** As a result of previous repeated overexposures or a single large dose, certain individuals develop isocyanate sensitization (chemical asthma) which will cause them to react to a later exposure to isocyanate at levels well below the TLV. These symptoms, which can include chest tightness, wheezing, cough, shortness of breath, or asthma attack, could be immediate or delayed (up to several hours after exposure). Similar to many non-specific asthmatic responses, there are reports that once sensitized and individual can experience these symptoms upon exposure to dust, cold air, or other irritants. Sensitization can be temporary or permanent.

**Ingestion:** Single dose oral toxicity is considered to be low. No hazards anticipated from swallowing small amounts incidental to normal handling operations.

Neither MDI nor polymeric MDI are listed by the NTP, IARC or regulated by OSHA as carcinogens.

If burned, treat as thermal burn. Ingestion: Treat symptomatically. MDI has a very low oral toxicity. There is no specific antidote. Inducing vomiting is contraindicated because of the irritating nature of this compound. Respiratory: This compound is a known pulmonary sensitizer. Treatment is essentially symptomatic. An individual having a skin or pulmonary sensitization reaction to this material should be removed from exposure to any isocyanate.

**Sensitization:** MDI has been shown to produce dermal sensitization in laboratory animals. Evidence of respiratory sensitization has also been observed in guinea pigs. In addition, there is some evidence suggestive of cross-sensitization between different types of diisocyanates.  
**Chronic Toxicity:** In a combined chronic inhalation toxicity/oncogenicity study, rats were exposed to an aerosol of polymeric MDI for 6 hours per day, 5 days per week for one or two years. The exposure concentrations were 0, .2, 1, and 6 mg/m3. Microscopic examination of tissues revealed the effects of irritation to the nasal cavity and lungs in animals exposed to 1 and 6 mg/m3. The No Observable Effect Level (NOEL) was .2 mg/m3.
