2.2 Danger Identification

Because of epoxy-product properties and according to the toxicological data available for similar products, this preparation may sensitize and irritate the skin and the respiratory system.

It contains epoxy components at low molecular weights, which may irritate eyes, mucosas and skin. Frequent contact with skin may cause irritation and sensitization phenomena. Sensitization reactions may also be caused by other epoxy components (cross-sensitization).

Avoid contact with skin and exposure to vapours and aerosols.

4. First aid measures

EYES: Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

SKIN: Wash immediately with plenty of water. Remove contaminated clothing. If irritation persists, seek medical attention. Wash contaminated clothing before using them again.

5. Fire-fighting measures

GENERAL INFORMATION

PERSONAL PRECAUTIONS

Use inert absorbent material (sand, vermiculite, diatomeous earth, Kieselguhr, etc.) to soak up leaked product. Collect the majority of the remaining material and deposit it in containers for disposal. If there are no contraindications, use jets of water to eliminate product residues. Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

7. Handling and storage

Store in a well ventilated place, keeping the containers closed when not used. Do not smoke while handling. Keep far away from sources of heat, bright flames and sparks and other sources of ignition.

8.2 Exposure controls

As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through effective local aspiration or bad air vent. If such operations do not make it possible to keep the concentration of the product below the permitted workplace exposure thresholds a suitable respiratory tract protection must be used. HAND PROTECTION

Protect hands with category II (ref. Directive 89/686/EEC and standard EN 374) work gloves, such as those in PVC, neoprene, nitryl or equivalent. The following should be considered when choosing work glove material: degradation, breakage times and permeation. Work glove resistance to preparations should be checked before use, as it can be unpredictable. Gloves' limit depends on the duration of exposure.

EYE PROTECTION

SKIN PROTECTION

Wear category II professional long-sleeved overalls and safety footwear (ref. Directive 89/686/CEE and standard EN 344). Wash body with soap and water after removing overalls.

RESPIRATORY PROTECTION

If the threshold value for one or more of the substances present in the preparation for daily exposure in the workplace or to a fraction established by the company's prevention and protection service is exceeded, wear a mask with an B or universal filter, the class (1, 2 or 3) of which must be chosen according to the limit concentration of use (ref. standard EN 141).

The use of breathing protection equipment, such as masks with organic vapour and dust/mist cartridges, is necessary in the absence of technical measures limiting worker exposure. The protection provided by masks is in any case limited.

If the substance in question is odourless or its olfactory threshold is higher than the relative exposure limit and in the event of an emergency, or when exposure levels are unknown or the concentration of oxygen in the workplace is less than 17% volume, wear self-contained, open-circuit compressed air breathing apparatus (ref. standard EN 137) or fresh air hose breathing apparatus for use with full face mask, half mask or mouthpiece (ref. standard EN 138).

10. Stability and reactivity

The product is stable in normal conditions of use and storage. When heated or in the event of a fire, carbon oxides may be released and vapours which are dangerous to health. The vapours may also form explosive mixtures with the air.

11. Toxicological information

Acute effects: stinging eyes. Symptoms may include: rubescence, edema, pain and lachrymation. Contact with skin may cause: irritation, erythema, edema, dryness and chapped skin. Vapour inhalation may slightly irritate the upper respiratory tract. Ingestion may cause health disorders, including stomach pain and sting, nausea and sickness. Upon contact with skin, this product causes sensitization (dermatitis). Dermatitis derives from skin irritation on the areas which repeatedly come into contact with the sensitizing agent. Cutaneous lesions may include: erythemas, edemas, papules, vesicles, pustules, scurvies, ulcerations and exudative phenomena, whose intensity varies according to illness seriousness and affected areas. Erythemas, edemas and exudative phenomena prevail during the acute phase. Scurfy skin, dryness, ulcerations and skin thickening prevail during the chronic phase.

This product must be handled carefully because of its possible mutagenic effects. Anyway, currently available data are insufficient to definitively prove hereditary gene alterations.

12. Ecological information

This product is dangerous for the environment and is toxic for aquatic organisms. In the long term, it may even have negative effects on acquatic environment.

13. Disposal consideration


